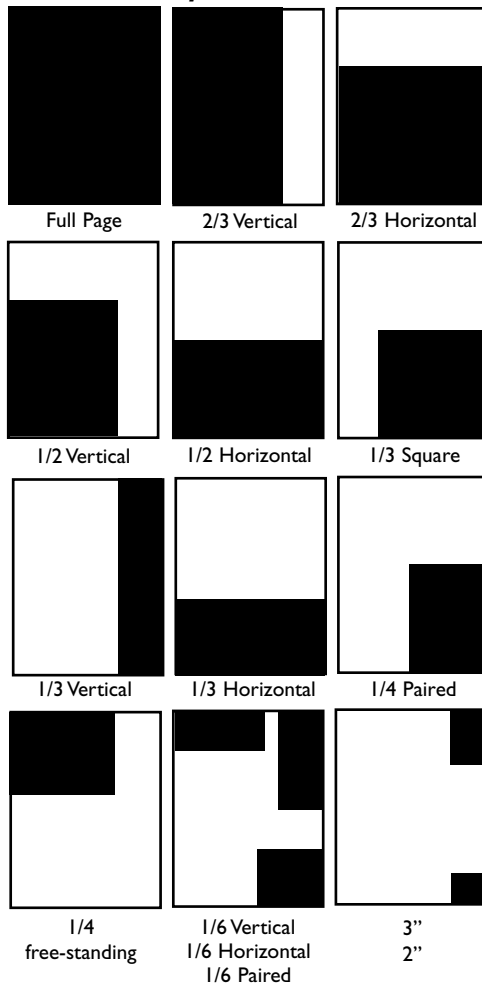

**\*\* Photos:** We can use either black/white or color prints, slides, negatives or high resolution digital images. Please **DO NOT** glue, tape, or staple your photos to your ad layout. **For best results please send ORIGINAL PHOTOS, or high resolution jpgs (300 d.p.i. or higher) if e-mailing photos. NO injet printouts of photos, please.** We can use original photos of any size. They can be enlarged or reduced as needed or cropped. The easiest way to indicate crop lines is with post-it notes. Make sure all photos, logos and clip art are of the best quality. Your original photos will be returned after the publication has mailed.

**Repeat Copy:** In the case of a contract advertiser, we would prefer to hear from you in accordance with the ad deadlines for each issue. We do, however, reserve the right to repeat the previous ad if no new copy is submitted, or update it or extend the contract, whichever appears most sensible in our judgement.

**Submitting Ads:** If you are providing a finished "ready-to-go" ad, it must be to our **EXACT** specifications. Please let us know the ad size and whether the ad is intended to be color or black/white. Macintosh users can submit ads by CD or DVD; NO NEGATIVES will be accepted. Ads provided by e-mail or on CD/DVD can be Macintosh Quark files (version 5 or earlier), Adobe InDesign files, TIFFs, JPEGs or PDFs. (See E-mail requirements below. Due to download errors/time/quality concerns, we prefer ads on disk, rather than by e-mail.) When making PDFs, please "include all fonts" in your PDF file. Ads will run as they are provided. If you are sending a full page bleed ad, contact our advertising department beforehand. **Always follow up with a phone call when sending ads.**

**Tear Sheets:** One tear sheet will be supplied to each display advertiser upon publication.

**Terms and Conditions:** Payment must accompany orders for first time advertisers. This includes individuals who have not advertised in the past four publications. All other accounts become due and payable upon publication. Interest charges of 1.5% monthly will apply on unpaid accounts ninety days after publication and continue to accrue until paid in full.

**E-mail:** If you would like to send photos\*\* or ads by e-mail, please contact us first for exact specifications and to let us know it is coming. **Always follow up with a phone call to be sure that we received your files and that they are usable/correct.**
