



### GENERAL PROVISIONS

The Iowa Percheron Futurity is an incentive program for owners of Percheron horses registered with the Percheron Horse Association of America and/or the Canadian Percheron Horse Association and exhibited at the Iowa State Fair, Des Moines, Iowa.

#### ELIGIBILITY – WEANLING FOAL:

- 1) In order to participate in the Futurity, unborn foals must be nominated by December 31 of the year prior to their birth.

A completed Iowa Percheron Futurity Application, nomination fee of \$50 and copy of the dam's registration paper must be on file with the Futurity Secretary by December 31 for each foal to be nominated for participation in the Futurity (i.e. December 31, 2008 for a foal born in 2009). The Futurity rights of the mare are for the upcoming foaling year and cannot be postponed to a different year under any circumstance.

- 2) A copy of the registration papers for the nominated foal must be on file with the Futurity Secretary by July 1. No pending registrations will be accepted.

If the foal's registration papers are not on file by July 1, it will become ineligible for future participation in the Futurity unless a reinstatement penalty of \$100 is paid.

- 3) In the event of a sale of the bred mare and/or nominated foal, eligibility for the current year is transferable to the new owner. It is the responsibility of the new owner to provide an updated copy of the foal's registration papers to the Futurity Secretary prior to July 1.
- 4) Entrants must meet and comply with all entry and exhibitor requirements of the Iowa State Fair as listed in the Iowa State Fair premium book.

#### FUTURITY CLASSES AND PURSES

- 1) The Iowa Percheron Futurity classes will be held at the Iowa State Fair, Des Moines, Iowa. Classes offered will be as follows:

- **Iowa Percheron Futurity Filly Foal**
- **Iowa Percheron Futurity Stallion Foal**
- **Iowa Percheron Futurity Supreme Foal\***

*\* open to first and second place Futurity filly and stallion foals*

- 2) Horses participating in the Iowa Percheron Futurity classes may also enter the open classes.
- 3) Futurity class entries must be made on the official Iowa State Fair entry form and must be mailed to the Iowa State Fair Horse Show Office no later than July 1. There are no entry fees for the Futurity classes. The exhibitor will be responsible for any stalling, admission, parking or other related expenses administered by the Iowa State Fair.
- 4) The official judge will be listed in the Iowa State Fair premium book.

- 5) The Futurity purses will be awarded to the individual(s) listed as the owner of the nominated foal on file with the Futurity secretary – no exceptions allowed. The Iowa Percheron Futurity will not be responsible for any ownership disputes.
- 6) The first place foal in the filly and stallion Futurity classes are guaranteed a sponsored \$1,000 purse. Purses for foals placing second through tenth will be paid a percentage of the additional sponsorships, nomination and related fees collected. A preliminary premium schedule is printed below. This schedule may be adjusted based on sponsorships. 10% of the nomination and related fees will be retained by the Futurity for use in defraying office expenses.
  - **1st: \$1,000**
  - **2nd: 15%**
  - **3rd: 10%**
  - **4-6th: 4%**
  - **7-10th: 2%**

#### **OTHER**

- 1) Deadline dates listed are determined by postmark date (i.e. December 31). Postage meters are not considered valid postmarks.
- 2) There will be absolutely no refunds of nomination or related fees. No exceptions.
- 3) A service charge of \$25 will be required for a returned check. Failure to pay this service charge and honor the check within 30 days of notification will result in disqualification without recourse of the nominations or related fees covered by that check.
- 4) Protests related to parentage verification or similar complaints will be handled in accordance with the Iowa State Fair protest policy published in the Iowa State Fair premium book.
- 5) All owners and exhibitors of Futurity nominated dams and foals have the right to display the Iowa Percheron Futurity logo in their advertising and promotional materials.

#### **FUTURITY DEADLINES**

##### ***December 31, 2008:***

- Application, nomination fee and copy of dam's registration papers must be on file.

##### ***July 1, 2009:***

- Copy of registration paper for 2009 foal must be on file. Foals without registration papers on file become ineligible and can only be reinstated through payment of penalty.
- Official Iowa State Fair entry must be mailed to the Iowa State Fair Horse Show Office.

##### ***December 31, 2009:***

- Application, nomination fee and copy of dam's registration papers must be on file for 2010 foal.
